






Public Market Perception

Crypto companies trade at a significant premium to gaming.





Market Opportunity

Combining two of the largest global market segments.

- NFT Market Growth: NFT sales for 2024 totalled \$8.8 billion, already surpassing the previous year's figure by over \$100 million.
- Gaming Industry Size: The global gaming market exceeds \$200bn and grows by 10% annually.
- Crypto Market Expansion: The cryptocurrency market is valued at over \$3.3tn and continues to see strong investment in gaming-related assets.





Raised for games via Kickstarter, highlighting a need for a pre-sale engine.



Problem

Issues in Game Development Funding.

- Traditional crowdfunding sites give rewards but little ongoing value.
- Steam limits developers' ability to launch pre-sales for games.
- Many NFT-based gaming projects focus more on speculation than actual gameplay.
- Gamers often feel disconnected from the funding process, reducing engagement.
- Crowdfunding platforms do not provide long-term funding solutions for game development.



Solution - MintPlay

A New Way to Crowdfund Games.

- Provides continuous funding for developers.
- Crowdsources risk for funding games, usually borne by studios & publishers.
- Rewards supporters with revenue-sharing opportunities.
- Offers both in-game and real-world benefits for NFT holders.
- Implements dynamic NFT pricing for sustainable growth.
- Strengthens community engagement by allowing NFT holders to benefit directly from game success.



How It Works

Dynamic NFT Supply & Pricing.

- Continuous Minting: NFTs are available anytime with dynamically adjusting prices.
- Bonding Curve Pricing: Prices increase algorithmically as more NFTs are minted, ensuring fair access and preventing artificial scarcity.
- Early Adopter Benefits: Initial backers secure lower-priced NFTs, incentivizing early investment and long-term holding.
- Market-Driven Pricing: Prices adjust based on demand, balancing availability and exclusivity.
- Long-Term Growth: As game popularity rises, NFT values increase, generating sustained funding and reinforcing project viability.



Companion Collectibles

Collectible Memecoins

- Speculative Markets: Memecoins supported by traditional Marketing and hype around game updates and launches.
- Massive Memecoin Market: For reference, the 1000th largest memecoin has a Market Cap of US\$25M, FDV (Fully Diluted Value) of US\$50M.
- New Game, New Coin: Each new game provides an opportunity to build hype and a new collectible set, supported by real marketing efforts.
- Community-Friendly Tokenomics: Supply largely community-oriented with small, vested carve outs for the Studio, Publisher, and MintPlay. Supports long-term value creation and community involvement, while maintaining massive top-end value potential.



Revenue Model

Revenue Sharing with NFT Holders.

MintPlay's revenue model is built on multiple income streams, ensuring financial stability and sustainable growth.

- NFT Sales: The core revenue driver, where players and investors purchase dynamic NFTs that grow in value
- In-Game Purchases: Players can buy exclusive skins, digital assets, and premium content.
- Advertising & Sponsorships: Partnerships with gaming and blockchain brands to feature in-game promotions and sponsorship deals.
- Marketplace Fees: MintPlay takes a percentage of secondary NFT sales, generating continuous passive revenue.
- Subscription Model: A premium membership offering exclusive perks, such as early access to new games, limited-edition NFTs, and VIP content.
- Revenue-Sharing Mechanism: A unique model where a percentage of all game-generated revenue is distributed back to NFT holders, ensuring long-term engagement.
- Companion Collectibles: Speculative markets with massive upside potential, supported by traditional marketing & hype for the games



Revenue Split

MintPlay revenue is distributed among all stakeholders.

- 50% reinvested into game development, or for new project launches.
- 15% reinvested into game publisher, to support marketing & distribution
- 15% allocated for platform maintenance, operational costs, and security enhancements.
- 15% dedicated to strategic partnerships, research, and future innovations in blockchain gaming.

By integrating a multi-stream revenue model with strategic reinvestment, MintPlay ensures a stable, thriving ecosystem that benefits both developers and the gaming community.



Revenue Projections

Y1 Projections: \$14.8M

- Pre-Sales & Perk Purchases: \$2M on \$30M expected game sales
- Revenue-Share NFT Purchases: \$6M on \$30M expected game sales
- Time-Value of Held Capital (5% avg return): \$400k
- Collectible Memecoin Market (40% stakeholder supply): \$6M on \$15M FDV
- Marketplace Fees on NFT Trading: \$400k



Utility and Benefits

- Exclusive Digital Content: Players can access limited-edition skins, weapons, in-game assets, and early beta testing opportunities.
- Real-World Perks: NFT holders gain access to exclusive merchandise, physical collectibles, and invitations to gaming events, meetups, and VIP experiences.
- Tradeable & Appreciating Assets: NFTs can be freely traded in secondary markets, allowing holders to profit from increasing value as the game ecosystem grows.
- Community-Driven Development: NFT owners can participate in governance decisions, vote on game updates, and engage in direct discussions with developers, ensuring player-driven innovation.
