Introduction

Collection of Information

Information You Provide to Us

- Contact details such as name, email address, mailing address, and phone number.
- Login credentials (username and password).
- Correspondence and other information you send to us.
- Any additional information disclosed at the point of collection.

Information We Collect Automatically

- Log files, including IP address, browser type, operating system, and usage data.
- Unique device identifiers and mobile device information.
- Cookies, web beacons, pixel tags, and similar technologies for tracking user behavior.

Information We Collect from Third Parties

- Publicly available information from directories and websites.
 - Data provided by our clients about their users, including name, email address, and phone number.

Use of Information and Legal Basis for Processing

We use the collected information to:

- Provide and improve our products and services.
- Analyze user interactions with our Websites and Online Services.
- Register and authenticate users.
- Communicate with users and respond to inquiries.
- Prevent fraud and ensure security.
- Comply with legal obligations.
- Conduct investigations related to violations of our terms and policies.
- Perform functions requested by you or our clients.

Some of our Websites use cookies to track usage patterns and enhance navigational structures for a better user experience.

Information Sharing and Disclosures

We share your information with third parties when:

- You provide consent.
 - It is necessary to deliver our services.
 - It is required by law or legal processes.
 - It is needed to enforce our Terms of Service or protect the safety of individuals or the public.
 - MINTplay undergoes a merger, acquisition, or sale requiring the transfer of personal data.

Your Choices

- Withdraw consent for data processing where applicable.

European Economic Area (EEA) Residents
